- Children under 6 years of age should be supervised when using products.

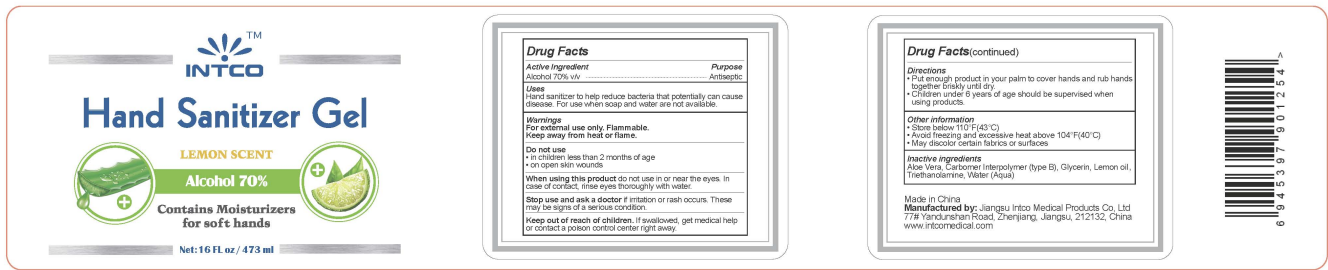
