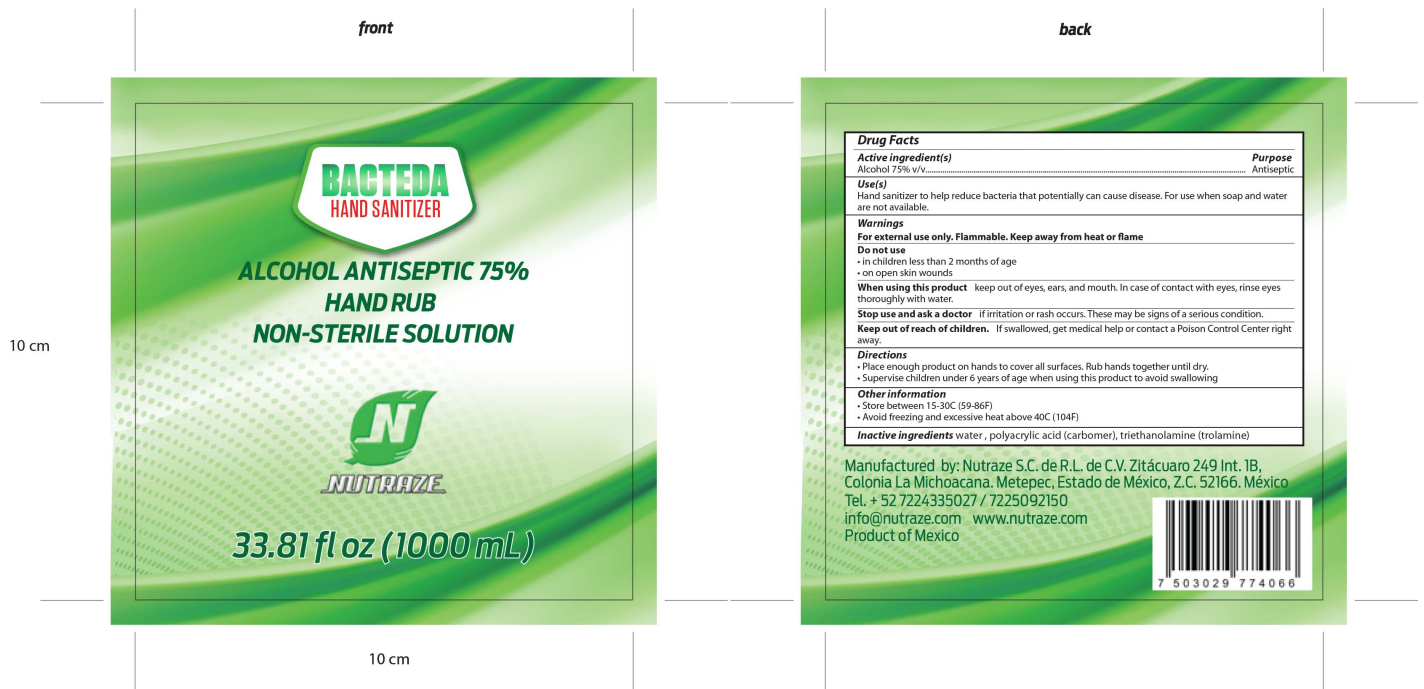

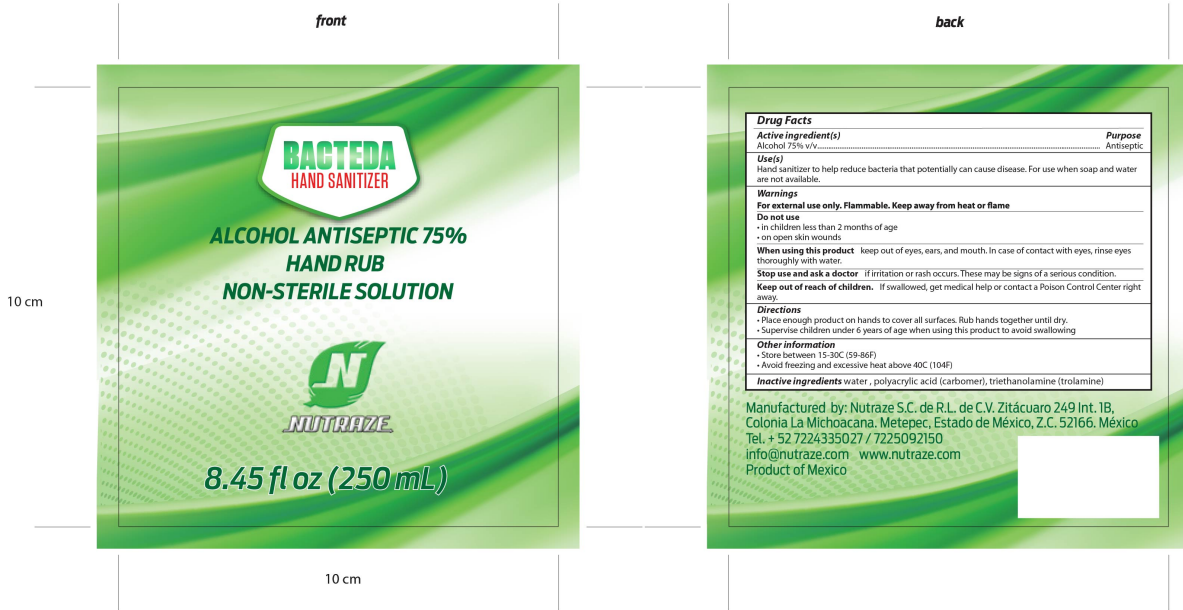

Package label- Principal Display Panel

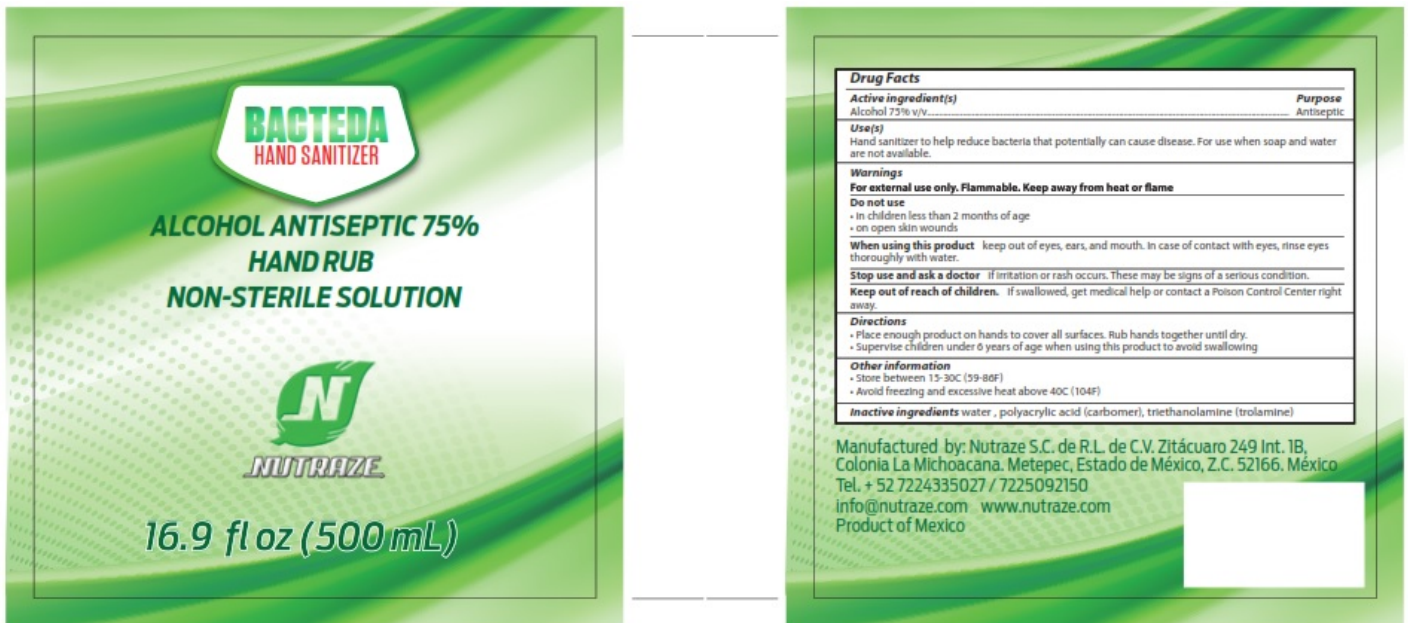
