- b. Glycerol (1.45% v/v).
- c. Hydrogen peroxide (0.125% v/v).
- d. Sterile distilled water or boiled cold water.

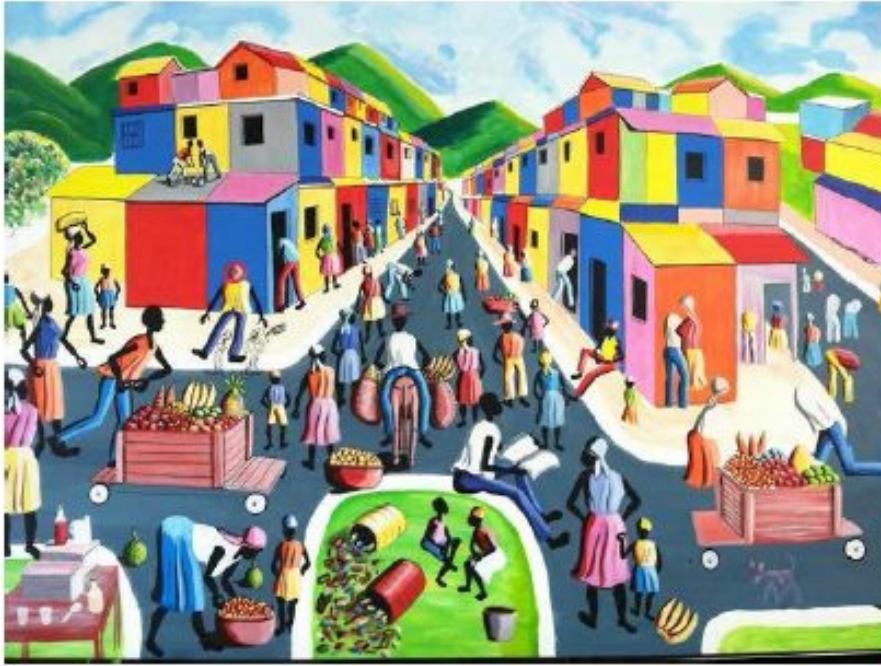
