Nasal Decongestant

#### **Uses**

Temporarily relieves nasal congestion due to:

- common cold
- hay fever

**Directions**

- Before using for the first time, remove the protective cap from the tip and prime the pump by depressing pump firmly several times. To spray, hold bottle with thumb at base and nozzle between first and second fingers. Without tilting head, insert nozzle into nostril. Fully depress rim with a firm and even stroke, and sniff deeply.
- Wipe nozzle clean after use.
- Adults and children 6 to under 12 years of age (with adult supervision): 2 or 3 sprays in each nostril not more than every 10 to 12 hours. Do not exceed 2 doses in any 24-hour period.
- Children under 6 years of age consult a doctor.

**To Use:** Shake well before use. Before using the first time, prime metered pump by depressing pump firmly several times. Squeeze both sides of the cap and twist counterclockwise. Align the lines on the groove at the base of the pump as shown in picture. Without tilting head, insert nozzle into nostril. Depress and spray. Fully depress rim with a firm, even stroke and sniff deeply. Wipe nozzle clean after use. Secure cap after use.
