- a. Alcohol (ethanol) (USP or Food Chemical Codex (FCC) grade) (73%, volume/volume (v/v)) in an aqueous solution denatured according to Alcohol and Tobacco Tax and Trade Bureau regulations in 27 CFR part 20.
- b. Glycerol (1.% v/v).
- c. Carbopol - 0.45%, Triethanolamine 0.25%
- d. Sterile distilled water or boiled cold water.
