Close lid after each use to keep wipes fresh

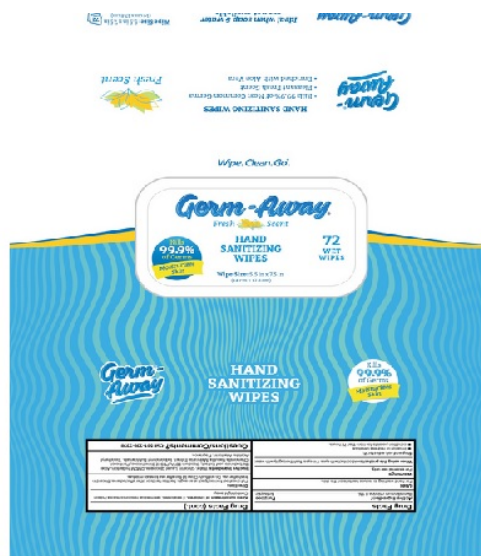
