Allergy alert: Aspirin may cause a severe stomach bleeding. The chance is higher if you:

- are age 60 or older
- have had stomach ulcers or bleeding problems
- take a blood thinning (anticoagulant) or steroid drug
- take other drugs containing prescription or nonprescription NSAIDs [aspirin, ibuprofen, naproxen, or others]
- have 3 or more alcoholic drinks every day while using this product
- take more or for a longer time than directed

Do not use

• if you are allergic to aspirin, or any other pain reliever/fever reducer

Ask a doctor before use if

• you have asthma

- stomach bleeding warning applies to you
- you have a history of stomach problems, such as heartburn
- you have high blood pressure, heart disease, liver cirrhosis or kidney disease
- you are taking a diuretic

Ask a doctor or pharmacist before use if you are

- taking a prescription drug for diabetes, gout, or arthritis
- taking any other drug or are under a doctor's care for any serious condition

Stop use and ask a doctor if:

1. you experience any of the following signs of stomach bleeding:

- feel faint
- have bloody or black stools
- vomit blood
- have stomach pain that does not get better

2. an allergic reaction occurs.

- seek medical help right away.
- 3. ringing in the ears or loss of hearing occurs
- 4. pain gets worse or lasts for more than 3 days
- 5. redness or swelling present
- 6. new symptoms occur

These could be sign of a serious condition.

If pregnant or breast-feeding,

ask a health professional before use. It is especially important not to use aspirin during the last 3 months of pregnancy unless definitely directed to do so by a doctor because it may cause problems in the unborn child or complications during delivery.

Keep out of reach of children.

- 1. Itake 1 to 2 tablets every 4 hours while symptoms last
- 2. do not take more than 12 tablets in 24 hours unless directed by a doctor
- 3. do not use for more than 10 days unless directed by a doctor
- **Children under 12 years:** do not use unless directed by a doctor
