**Warnings**

**Do not use** if you cannot swallow without chewing

**Ask a doctor before use if you have**

- stomach pain, nausea or vomiting
- a sudden change in bowel habits that lasts more than two weeks

**When using this product**

- do not chew or crush tablet(s)
- do not use within 1 hour after taking an antacid or milk
- you may have stomach discomfort, faintness or cramps

**Stop use and ask a doctor if**

- you have rectal bleeding or fail to have a bowel movement after use of a laxative. These could be signs of a serious condition.
- you need to use a laxative for more than 1 week

**If pregnant or breast-feeding,** ask a health professional before use.

**Keep out of reach of children.** In case of overdose, get medical help or contact a Poison Control Center right away (1-800-222-1222).

- take with a glass of water

adults and children 12 years and over take 1 to 3 tablets in a single daily dose

children 6 to under 12 years of age take 1 tablet in a single daily dose

children under 6 years of age ask a doctor

- **each tablet contains:** magnesium 5mg
- store at 25°C (77F) excursions permitted between 15° - 30°C (59° - 86°F)
- use by expiration date on package
  - protect from excessive humidity
