Directions

- adults and children 5 years and over: dissolve 2 drops (one at a time) slowly in the mouth. Repeat every 2 hours as needed
- children under 5 years: ask a doctor.

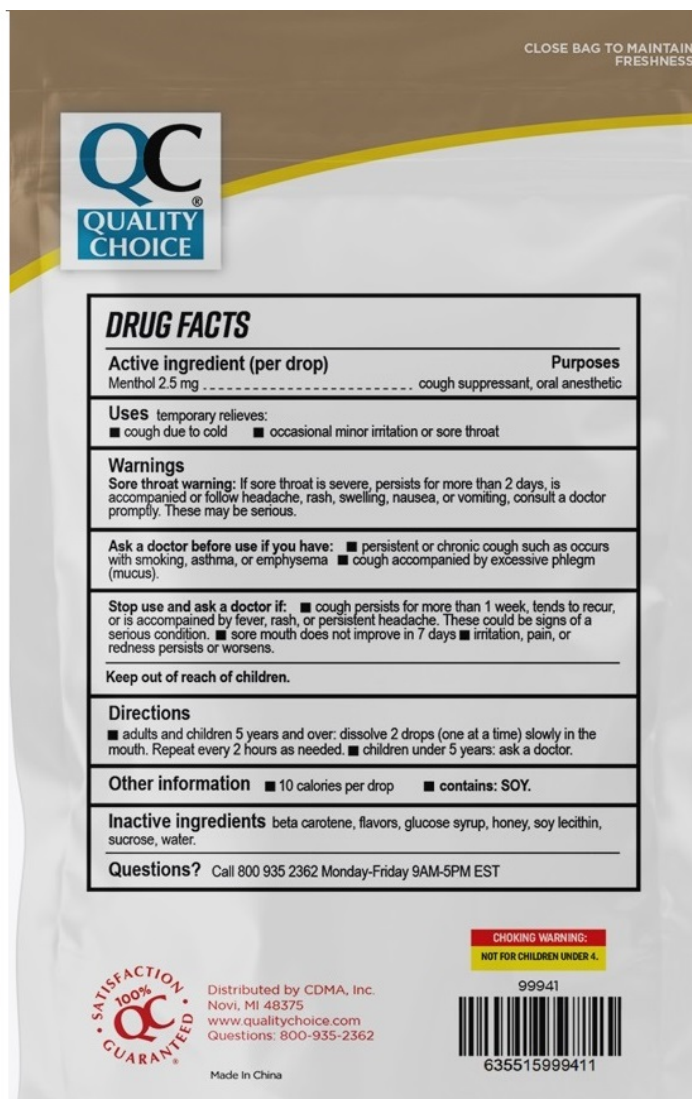
