**Stomach bleeding warning:** This product contains an NSAID, which may cause severe stomach bleeding. The chance is higher if you

- Are age 60 or older
- Have had stomach ulcers or bleeding problems
- Take a blood thinning (anticoagulant) or steroid drug
- Take other drugs containing prescription or nonprescription NSAIDs (aspirin, ibuprofen, naproxen or others)
- Have 3 or more alcoholic drinks everyday while using this product
- Take more or for a longer time than directed.

**Do not use**

- If you are allergic to aspirin or any other pain reliever/fever reducer.\
- If you have ever had an allergic reaction to this product or any of its ingredients.

**Ask a doctor before use if**

- Stomach bleeding warning applies to you
- You have a history of stomach problems such as heartburn
- You have high blood pressure, heart disease, liver cirrhosis, or kidney disease
- You are taking a diuretic
- You have asthma

**Ask a doctor or pharmacist before use** if you are taking a prescription drug for

- Gout
- Diabetes
- Arthritis

**Stop use and ask a doctor if**

- An allergic reaction occurs. Seek medical help right away.
- You experience any of the following signs of stomach bleeding:
- Feel faint
- Vomit blood
- Have bloody or black stools
- Have stomach pain that does not get better
- Pain gets worse or last more than 10 days
- Redness or swelling is present
- Fever gets worse or last more than 3 days
- New symptoms occur
- Ringing in the ears or loss of hearing occurs

**If pregnant or breast-feeding**, ask a health professional before use. It is especially important not to use aspirin during the last 3 months of pregnancy unless definitely directed to do so by a doctor because it may cause problems in the unborn child or complications during delivery.
