**Active ingredient (in each caplet)**

Acetaminophen 500 mg

**Purpose**

Pain reliever/fever reducer

**Uses**

- temporarily relieves minor aches and pains due to:
- the common cold
- headache
- backache
- minor pain of arthritis
- toothache
- muscular aches
- premenstrual and menstrual cramps
- temporarily reduces fever

**Warnings**

**Liver warning:** This product contains acetaminophen. Severe liver damage may occur if you take

- more than 4,000 mg of acetaminophen in 24 hours
- with other drugs containing acetaminophen
- 3 or more alcoholic drinks every day while using this product

**Allergy alert:** Acetaminophen may cause severe skin reactions. Symptoms may include:

- skin reddening
- blisters
- rash

If a skin reaction occurs, stop use and seek medical help right away.

**Do not use**

- with any other drug containing acetaminophen (prescription or nonprescription). If you are not sure whether a drug contains acetaminophen, ask a doctor or

pharmacist.

- if you have ever had an allergic reaction to this product or any of its ingredients

**Ask a doctor before use if you have**

liver disease

**Ask a doctor or pharmacist before use if you are**

taking the blood thinning drug warfarin

**Stop use and ask a doctor if**

- pain gets worse or lasts more than 10 days
- fever gets worse or lasts more than 3 days
- new symptoms occur
- redness or swelling is present

These could be signs of a serious condition.

**If pregnant or breast-feeding,**

ask a health professional before use.

**Keep out of reach of children.**

**Overdose warning:** In case of overdose, get medical help or contact a Poison Control Center right away (1-800-222-1222). Quick medical attention is critical for adults as well as for children even if you do not notice any signs or symptoms.

**Directions**

- **do not take more than directed (see overdose warning)**

adults and children 12 years and over	<ul style="list-style-type: none"><li>• take 2 caplets every 6 hours while symptoms last</li><li>• do not take more than 6 caplets in 24 hours, unless directed by a doctor</li><li>• do not use for more than 10 days unless directed by a doctor</li></ul>
children under 12 years	ask a doctor
