

[How to use] - [Activation]

The stick contains the first solution and ampoule (second powder).



- Bend the EasyStick™-Dr.K Shield to break the ampoule within. This enables the discharge of the active ingredient.
- Tear open the label along the dotted line for maximum strength, this increase the discharge of the active ingredient but shorten the usage period.
- When the liquid inside the EasyStick™-Dr.K Shield becomes transparent, replace it with another EasyStick™-Dr.K Shield and dispose the old stick with general waste.
- Effective Temperature: 4°C ~ 35°C

DO NOT Break open the EasyStick™ - Dr.K Shield to expose its contents.

Precautions while using the EasyStick™-Dr.K Shield

3. If the contents come into contact with your eyes or skin due to spillage from the EasyStick™-Dr.K Shield wash the affected area thoroughly with running water and immediately consult a doctor if discomfort occurs.

5. If the liquid spills onto your clothing, discolorations may occur.
