Teats and udders should be thoroughly washed and dried before milking*, using potable water and individual paper towels to prevent contamination of milk. Blot dry. 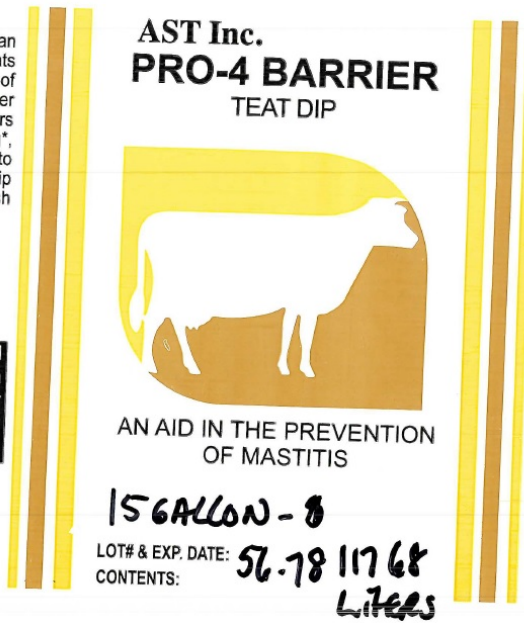
