INSTRUCCIONES:

Instrucciones para el sellado de pezones

Sellado del pezón previo al ordeño: Antes de ordeñar cada vaca, bañe toda la superficie de cada pezón en un recipiente que contenga QM Green fresco. Limpie los pezones con toallas de uso único luego del baño para evitar la contaminación de la leche.

Sellado del pezón posterior al ordeño: Bañe toda la superficie de cada pezón en un recipiente que contenga QM Green fresco. No utilice paños. Deje secar al aire. No deje las vacas en un clima helado hasta que el producto se haya secado por completo.

Use Expandido: Al refrescar a las vacas, comience con un baño antiséptico de sus pezones dos veces por día por aproximadamente 10 días antes de parir.
