Uses

temporarily:

- reduces fever

relieves minor aches and pains due to:

- headache
- sore throat

Warnings

Liver Warning: This product contains acetaminophen. Severe liver damage may occur if your child takes:

- more than 5 doses in 24 hours, which is the maximum daily amount
- with other drugs containing acetaminophen

Allergy alert: Acetaminophen may cause severe skin reactions. Symptoms may include:

- skin reddening
- blisters
- rash

If a skin reaction occurs, stop use and seek medical help right away.

Sore throat warning:

if sore throat is severe, persists or more than 2 days, is accompanied or followed by fever, headache, rash, nausea or vomiting, consult a doctor promptly.

Do not use

- with any other drug containing acetaminophen (prescription or nonprescription).
- If you are not sure whether a drug contains acetaminophen, ask a doctor or pharmacist.
- if your child is allergic to acetaminophen or any of the inactive ingredients in this product.

Ask a doctor or pharmacist before use if the child has

liver disease.

Ask doctor or pharmacist before use if your child is

taking the blood thinning drug warfarin. **When using this product do not exceed recommended dose (see overdose warning)**

Stop use and ask a doctor if

- pain gets worse or lasts for more than 5 days
- fever gets worse or last for more than 3 days
- new symptoms occur redness or swelling is present. These could be signs of a serious condition.

Overdose warning:

In case of overdose, get medical help to contact Poison Control Center (1-800-222-1222) right away. Quick medical attention is critical even if you do not notice any signs or symptoms.

Keep out of Reach of children

Directions

- this product does not contain directions or complete warnings for adult use
- shake well before using
- mL = milliliter
- find right dose on chart below. if possible, use weight to dose, otherwise use age
- use only the enclosed dosing cup designed for use with product.
- if needed, repeat dose every 4 hours while symptoms last
- do not give more than 5 times in 24 hours.
