For whole body application: Dispense 1 or 2 pumps onto your palm and massage on the skin and hair. Massage into the skin until fully penetrated. Repeat as necessary to cover the whole body, avoiding the eyes and mouth. Do not rinse, let air dry. Once dry, brush the haircoat again.

Dosage:

Under 11 lbs: 1 pump per 2 lbs

11-88 lbs: 1 pump per 4 lbs

Over 88 lbs: 1 pump per 6 lbs

Dosage may be doubled for long-haired breeds. For deeper cleansing, use VetraSeb™ CeraDerm CK Shampoo.
