RECOMMENDED PROCEDURES FOR TEAT SANITATION:

A. PRE-MILKING (PRE-DIPPING)

1. Remove visible soils from the teats.
2. Observe for milk by stripping two or three streams of milk into a strip cup.
3. Dip or spray the cow's teats full length with **ASSURE-M** Teat Dip.
4. Wait approximately 30 seconds.
5. Remove all teat dip by thoroughly drying the teats and teat orifices and udder (if foaming or spraying) with a clean, single service paper towels(s).
6. Attach milking unit.

B. POST-MILKING (POST-DIPPING)

1. Immediately after milking, dip or spray all teats full length with **ASSURE-M** Teat Dip. Ensure good coverage of all sides of the teats and teat orifices.

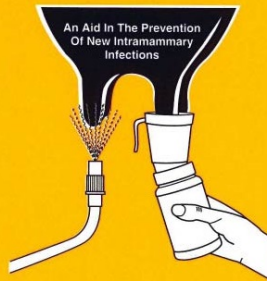
