Directions

- clean the affected area & dry thoroughly
- apply a thin layer of the product over affected area twice daily (morning and night) or as directed by a doctor
- supervise children in the use of this product
- for athlete's foot: pay special attention to the spaces between the toes, wear well-fitting, ventilated shoes, & change shoes & socks at least once daily
- for athlete's foot & ringworm, use daily for 4 weeks; for jock itch, use daily for 2

weeks

- if condition persists longer, consult a doctor
- this product is not effective on scalp or nails

Other information

- store between 20 ° - 25 °C (68 ° - 77 °F)
- lightly shake bottle to loosen settled powder

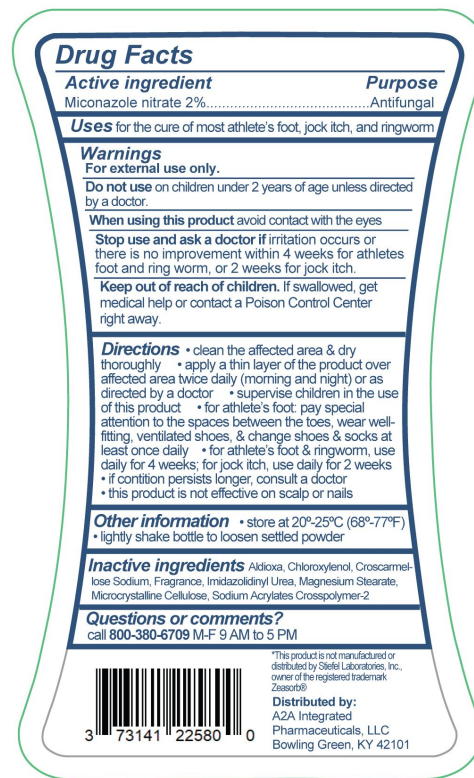

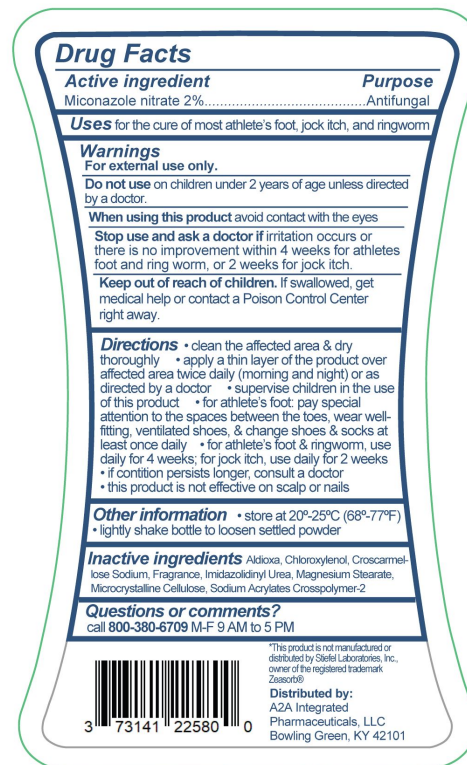
