How to Use (How to Activate)

As it turns yellow, the stick is activated and the pure chlorine dioxide is released through the surface of the stick.

After 3~4 weeks of usage, the stick will turn transparent which indicates that it is no longer effective. Please dispose the used stick into a general trash bag.

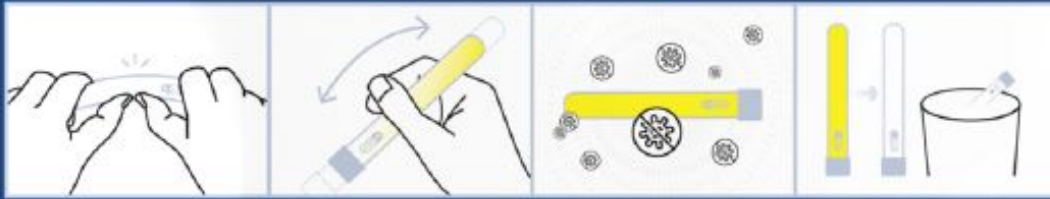


**How to Use (How to Activate)**

### Product Precautions

01. Do not forcibly break the stick.
02. Avoid prolonged contact with the skin.
03. Wash the contents clean with running water in case the stick breaks and causes contact with the skin. Consult a doctor immediately if any abnormality occurs.
04. If content is swallowed, first aid should be taken and a doctor shall be consulted immediately.
05. If content spills onto garment, there is a risk of bleaching.
06. Avoid places with water, moisture, heat and direct sun as it shortens the period of use.
07. Avoid direct contact with vegetables if product is placed inside a refrigerator.
08. Do not use the stick inside the freezer.
09. Use after ventilating if the smell is too strong or causes irritation.
