- Store at room temperature. Keep the container tightly closed.

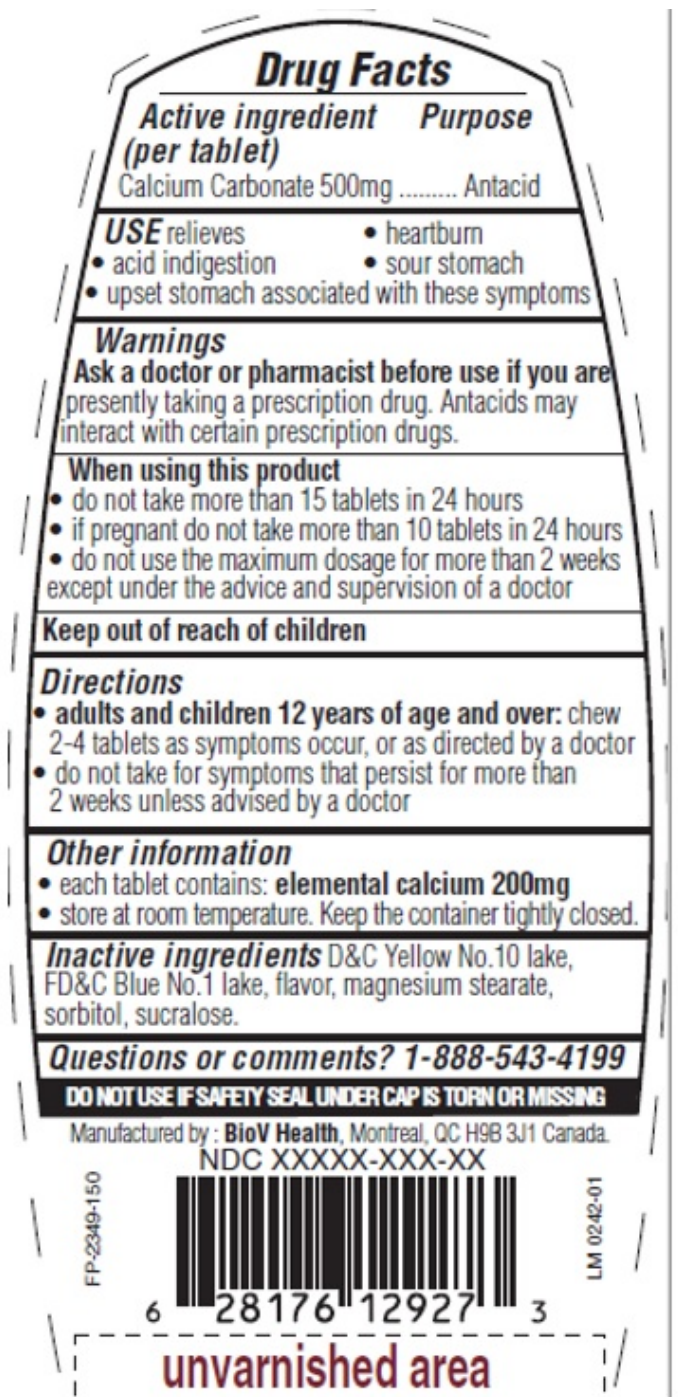
