### USAGE ADVICE

If you're noticing any signs of discomfort, such as dryness or flaking, reduce applications until any signs of irritation subside. If persistent irritation occurs, discontinue use.

Please note, this product has a light yellow colour due to the Retinol used in this formulation. It also has a soft odour given by the ingredient Sulfur.

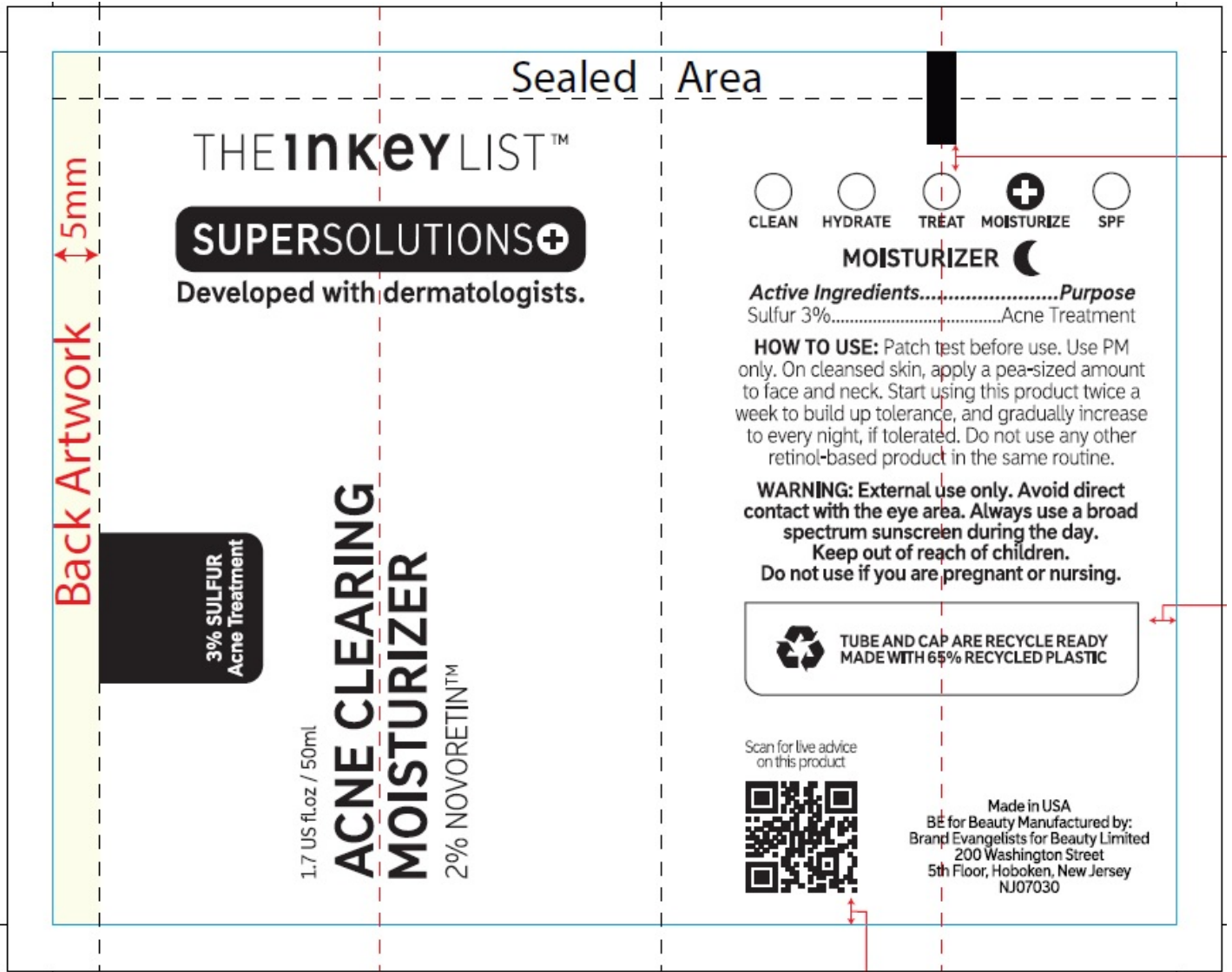
