### **Whisk Care 375**

This is a hand sanitizer manufactured according to the Temporary Policy for Preparation of Certain Alcohol-Based Hand Sanitizer Products During the Public Health Emergency (CoViD-19); Guidance for Industry.

The hand sanitizer is manufactured using only the following United States Pharmacopoeia (USP) grade ingredients in the preparation of the product (percentage in final product formulation) consistent with World Health Organization (WHO) recommendations:

- a. Alcohol (ethanol) (USP or Food Chemical Codex (FCC) grade) (80%, volume/volume (v/v)) in an aqueous solution denatured according to Alcohol and Tobacco Tax and Trade Bureau regulations in 27 CFR part 20.
- b. Glycerol (1.45% v/v).
- c. Hydrogen peroxide (0.125% v/v).
- d. Sterile distilled water or boiled cold water.

The firm does not add other active or inactive ingredients. Different or additional ingredients may impact the quality and potency of the product.

### PRECAUTIONARY MEASURES

### FIRST AID

**Eye Contact:** Immediately flush with water for at least 20 minutes. Do not use chemical antidote. Call a physician.

**Ingestion:** Do not induce vomiting. Give 2 glasses of water and seek medical attention immediately. Never give anything by mouth to an unconscious person.

**Skin contact:** Remove contaminated clothing and shoes and wipe excess from skin. Flush skin with water, then wash with soap and water. If irritation occurs, get medical attention. Do not reuse clothing until cleaned. If redness, swelling, pain and/or blisters occur, transport to the nearest Medical facility for additional treatment.

### FIRE

In case of fire, use water fog, "Alcohol Foam", dry chemical or carbon dioxide (CO<sub>2</sub>) to extinguish flames. Do not use a stream of water. Material will float and can be re-ignited on surface of water.

### SPILL OR LEAK

Eliminate all sources of ignition. Dike and contain spill.

**For Large Spills:** Remove with vacuum or truck pump to salvage vessel. Prevent material from entering drains, sewers or waterways. Dispose of in accordance with local, state and federal regulations.

**For Small Spills:** Soak up residue with an absorbent such as clay, sand or other suitable material, place in container and seal tightly for proper disposal.
