EDX-1000™ is a sanitizing iodine teat dip to aid in the prevention of the spread of mastitis causing organisms.

Use instructions:

Use full strength.

Pre-Dipping: Just before milking, make sure the teats are clean and dry. Dip each teat in undiluted **EDX-1000™**. Allow 5-30 seconds of contact time. Dry with a single service towel and attach milker units.

Post-Dipping: Immediately after removing inflations, dip each teat in undiluted **EDX-1000™**. Allow teat to air dry. Do not wipe.

Replace the solution if it becomes visibly dirty.

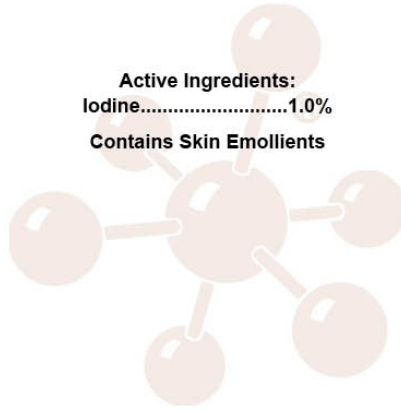
