- wear long-sleeved shirts, pants, hats, and sunglasses
- children under 6 months of age: Ask a doctor

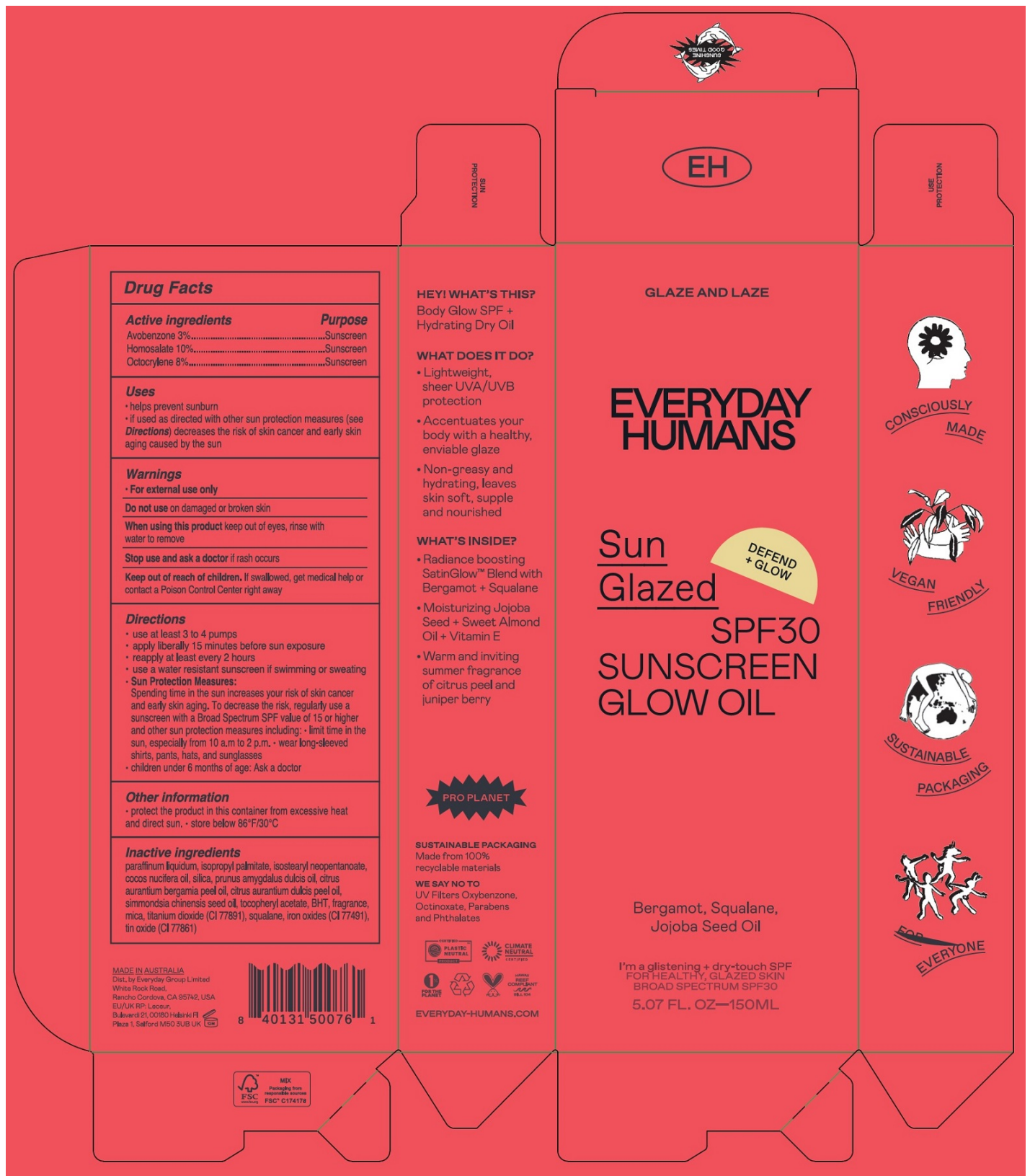
