Warnings

Reye's syndrome: Children and teenagers who have or are recovering from chicken pox or flu-like symptoms should not use this product. When using this product, if changes in behavior with nausea and vomiting occurs, consult a doctor because these symptoms could be an early sign of Reye's syndrome, a rare but serious illness.

Allergy alert: Contains salicylate. Do not take if you are

- allergic to salicylate (including aspirin)
- taking other salicylate products

Do not use if you have

- an ulcer
- a bleeding problem
- bloody or black stool

Ask a doctor before use if you have

- fever
- mucus in stool

Ask a doctor or pharmacist before use if you are taking any drug for

- anticoagulation (thinning of the blood)
- diabetes
- gout
- arthritis

When using this product a temporary, but harmless darkening of the stool and/or tongue may occur

Stop use and ask a doctor if

- symptoms get worse
- ringing in the ears or loss of hearing occurs
- diarrhea lasts more than 2 days

If pregnant or breast-feeding, ask a health professional before use.

Keep out of reach of children. In case of overdose, get medical help or contact a Poison Control Center (1-800-222-1222) right away.

Directions

- chew or dissolve in mouth
- **Adults and children 12 years and over:** 2 tablets (1 dose) every ½ hour or 4 tablets (2 doses) every hour as needed for diarrhea
- 2 tablets (1 dose) every 1/2 hour as needed for overindulgence (upset stomach, heartburn, indigestion, nausea)
- do not exceed 8 doses (16 tablets) in 24 hours
- use until diarrhea stops but not more than 2 days
- **Children under 12:** ask a doctor
- drink plenty of fluids to help prevent dehydration which may accompany diarrhea

Other information

- **Phenylketonurics:** contains phenylalanine 1.1 mg per tablet

Calcium content per tablet: 73mg

- store at room temperature 15° - 30°C (59° - 86°F)
- avoid excessive heat (over 40°C or 104°F)
- do not use if cellophane unit is torn

acacia gum, aspartame, calcium carbonate, D&C red #27 aluminum lake, dextrans, magnesium stearate, maltodextrin, microcrystalline cellulose, peppermint flavor, silicon dioxide


