- store at 59° to 77°F

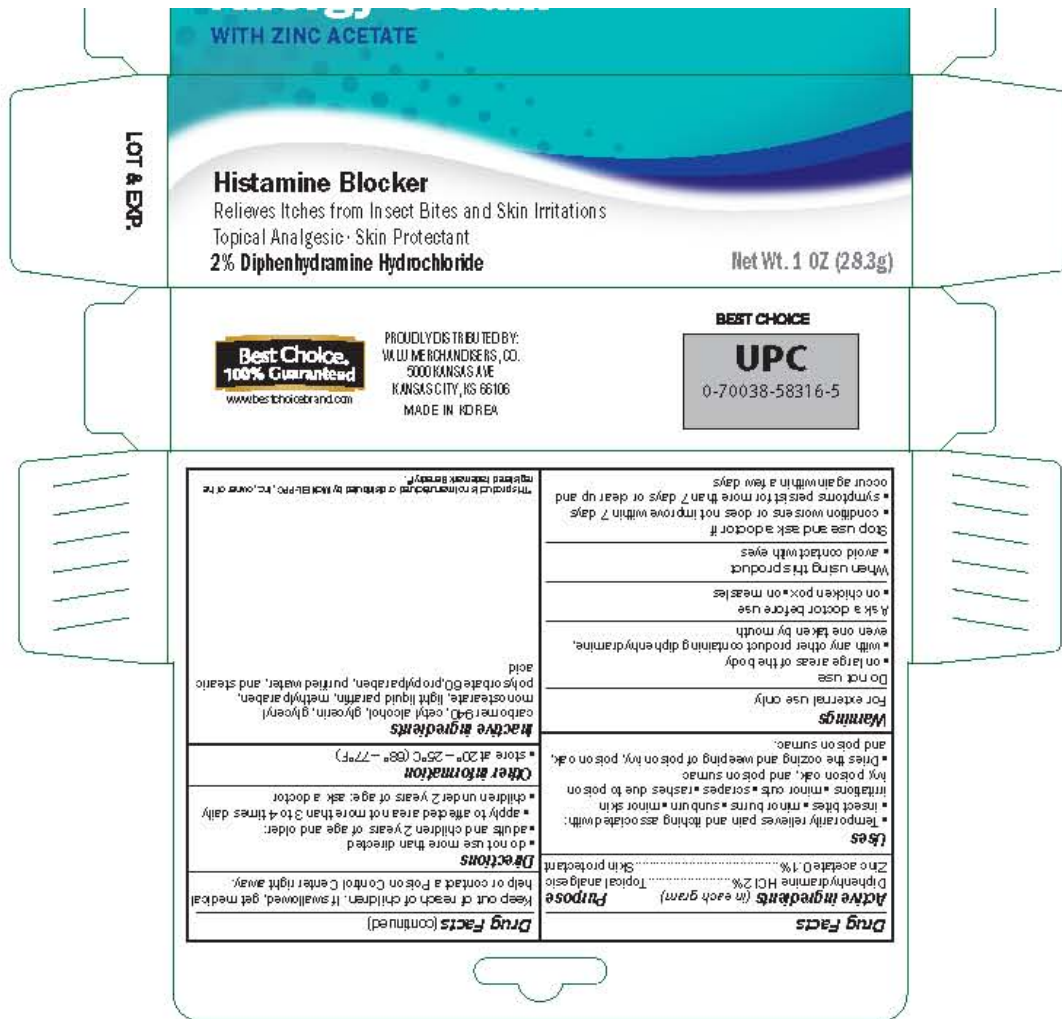
