- do not use if printed seal under cap is torn or missing

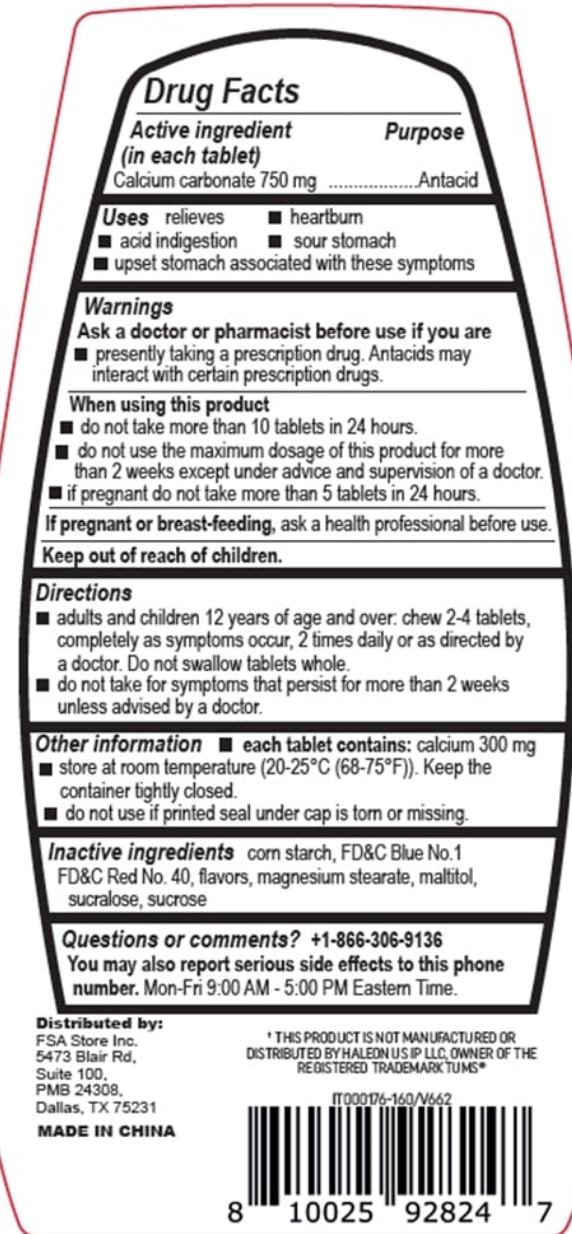
