- Replace Pad Liner with each maxi pad change.

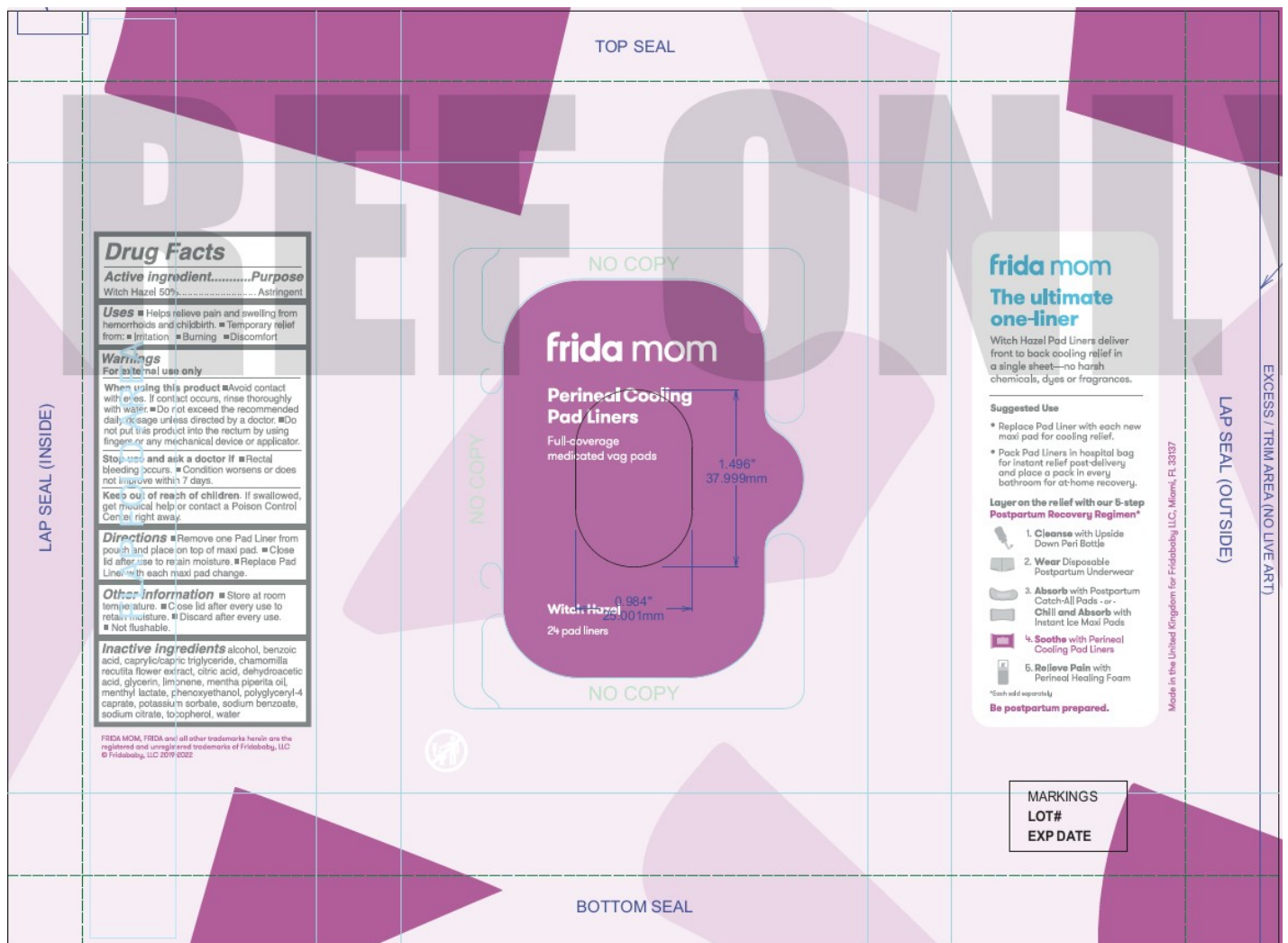
