May discolor certain fabrics.

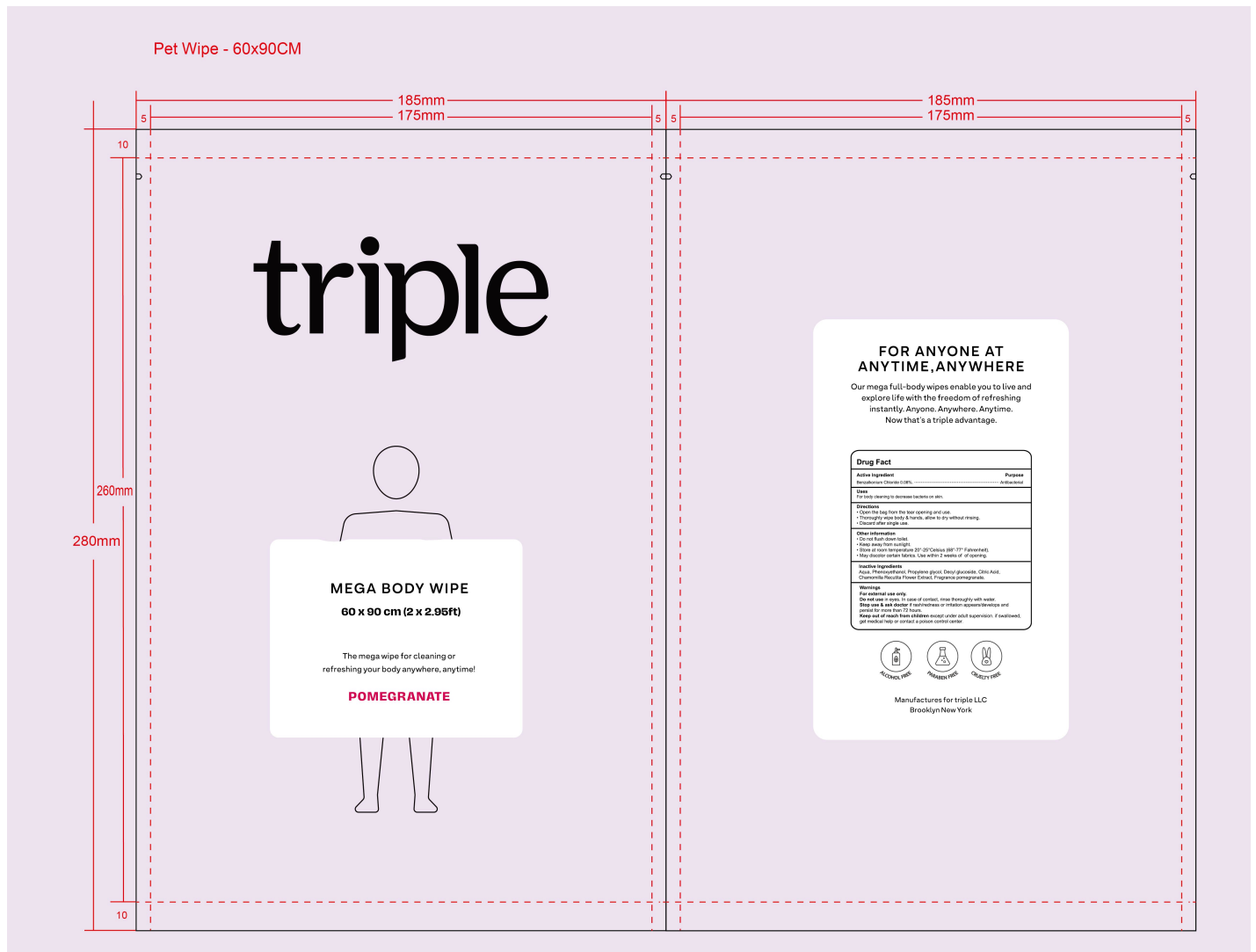
