Directions

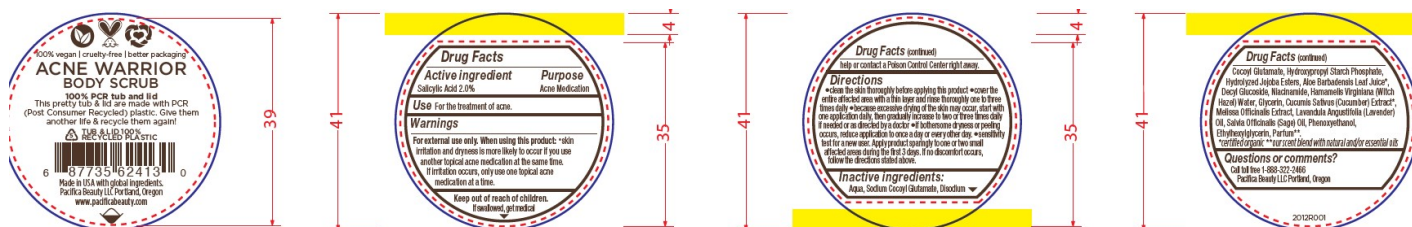
