Xpect Acetaminophen

Active ingredient (in each tablet)

Acetaminophen 500 mg

Purpose

Pain reliever/fever reducer

Uses

- temporarily relieves minor aches and pains due to: headache, the common cold, backache, minor pain of arthritis, toothache, muscular aches, premenstrual and menstrual cramps
- temporarily reduces fever

Warnings

Liver warning: This product contains acetaminophen. Severe liver damage may occur if you take

- more than 4,000 mg of acetaminophen in 24 hours
- with other drugs containing acetaminophen
- 3 or more alcoholic drinks every day while using this product

Allergy alert: Acetaminophen may cause severe skin reactions. Symptoms may include:

- skin reddening
- blisters
- rash

If a skin reaction occurs, stop use and seek medical help right away.

Do not use

- with any other drug containing acetaminophen (prescription or nonprescription). If you are not sure whether a drug contains acetaminophen, ask a doctor or pharmacist.
- if you are allergic to acetaminophen or any of the inactive ingredients in this product

Ask a doctor before use if you have

liver disease.

Ask a doctor or pharmacist before use if you are

taking the blood thinning drug warfarin.

Stop use and ask a doctor if

- pain gets worse or lasts more than 10 days
- fever gets worse or lasts more than 3 days
- new symptoms occur
- redness or swelling is present

These could be signs of a serious condition.

If pregnant or breast-feeding,

ask a health professional before use.

Keep out of reach of children.

In case of accidental overdose, get medical help or contact a Poison Control Center right away. Prompt medical attention is critical for adults as well as for children even if you do not notice any signs or symptoms.

Directions

- **do not take more than directed**
- adults and children 12 years and over: take 2 tablets every 6 hours while symptoms last; do not take more than 6 tablets in 24 hours, unless directed by a doctor; do not take for more than 10 days unless directed by a doctor
- children under 12 years: ask a doctor

Other information

- store at 25°C (77°F); excursions permitted between 15°-30°C (59°-86°F)
- see packet for expiration date and lot number

castor oil, corn starch, hypromellose, polyethylene glycol, povidone, pregelatinized starch, sodium starch glycolate, starch, steric acid, titanium dioxide
