Purpose

Wart remover

Use

for the removal of common warts. The common wart is easily recognized by the rough 'cauliflower-like' appearance of the surface.

Warnings

For external use only.

Ask a doctor before use if you have

- diabetes
- poor blood circulation

Do not use on

- irritated, infected or reddened skin
- genital warts and warts on face
- moles, birthmarks and warts with hair growing from them
- mucous membranes

Keep out of reach of children

If swallowed, get medical help or contact a Poison Control Center right away.

Stop and ask a doctor

If discomfort persists

Directions

- wash affected area, may soak wart in warm water for 5 minutes
- dry area thoroughly
- if necessary, cut medicated patch to fit wart
- apply adhesive side down of patch onto wartcover patch with pad to conceal area
- repeat this procedure every 48 hours as needed (until wart is removed) for up to 12

weeks

Other information

store between 59°F to 86°F (15°C to 30°C)

Inactive ingredients

acrylic adhesive, acrylic polymer, polyethylene, polyvinyl alcohol.
