Phenazopyridine Hydrochloride 99.5 mg .

Urinary Analgesic

**Warnings**

**Ask doctor before use if you have**

- kidney disease
- allergies to food, preservatives or dyes
- had a hypersensitive reaction to phenazopyridine

**When using this product**

- stomach upset may occur, taking this product with or after meals may reduce stomach upset
- your urine will become reddish-orange in color. This is not harmful, but care should be taken to avoid staining clothing or other items.

**Stop use and ask doctor if**

- your symptoms last for more than 2 days
- you suspect you are having an adverse reaction to the medication

**If pregnant or breast feeding,**

Ask a health professional before use.

## **Keep out of reach of children**

In case of an overdose, get medical help or contact a Poison Control Center right away.

## **Use**

Fast relief from urinary pain, burning, urgency and frequency associated with urinary tract infections.

## **Inactive ingredients**

Lactose, magnesium silicate, magnesium stearate, microcrystalline cellulose, pharmaceutical glaze, and sodium starch glycolate.

## **Directions**

- adults and children 12 years and over:  
take 2 tablets 3 times daily with a full glass of water, with or after meals as needed
- children under 12 years: consult a doctor
- Do not use for more than 2 days (12 tablets) without consulting a doctor
