Purpose

Antigingivitis

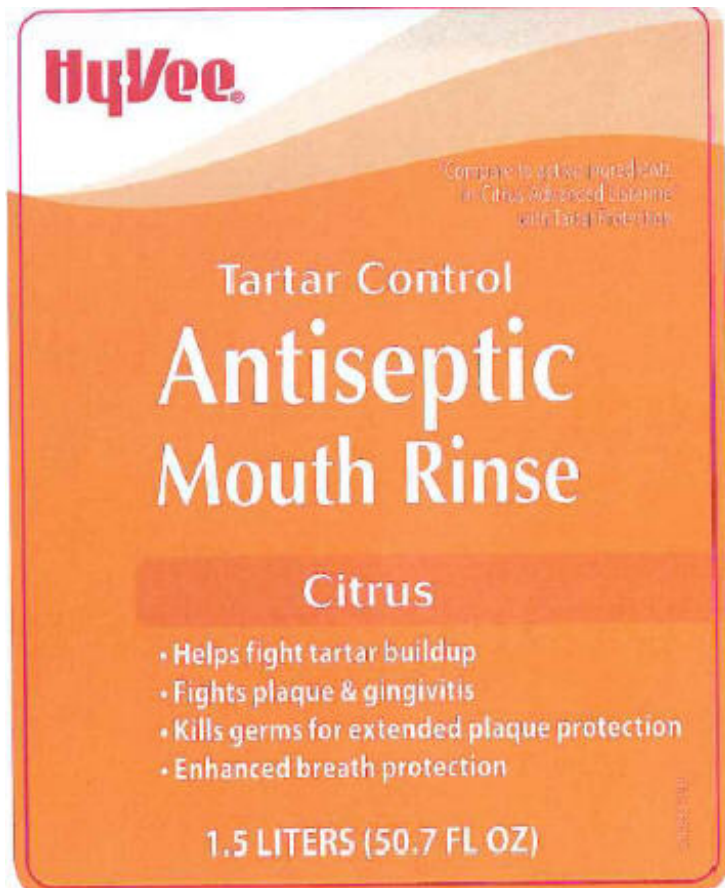
