Dear Mr. Fitzgerald:

Please refer to your supplemental new drug application (sNDA) dated and received December 7, 2009, submitted under Section 505(b) of the Federal Food, Drug, Cosmetic Act (FDCA) for Marcaine Spinal (bupivacaine HCl) dextrose injection.

Reference is also made to our letter dated November 12, 2009 notifying you, under Section 505(o)(4) of the FDCA, of new safety information that we believe should be included in the labeling for Marcaine Spinal (bupivacaine HCl) dextrose injection. This information pertains to the risk of chondrolysis in patients receiving intra-articular infusions of local anesthetics following arthroscopic and other surgical procedures.

This supplemental new drug application provides for revisions to the labeling for Marcaine Spinal (bupivacaine HCl) dextrose injection consistent with our November 12, 2009 letter.

We have completed our review of this application. This application is approved, effective on the date of this letter, for use as recommended in the agreed-upon labeling text.

CONTENT OF LABELING

To facilitate the transmission of labeling to the National Library of Medicine for public dissemination, please resubmit the enclosed content of labeling in SPL format as soon as possible, but no later than 14 days from the date of this letter. For administrative purposes, please designate this submission, "**SPL for approved NDA 18692/S-014.**"

We request that the revised labeling approved today be available on your website within 10 days of receipt of this letter.

Marketing the product with labeling that is not identical to the approved labeling text may render the product misbranded and an unapproved new drug.

PROMOTIONAL MATERIALS

All promotional materials for your drug product that include representations about your drug product must be promptly revised to make it consistent with the labeling changes approved in this supplement, including any new safety information [21 CFR 314.70(a)(4)]. The revisions to your promotional materials should include prominent disclosure of the important new safety information that appears in the revised package labeling. Within 7 days of receipt of this letter, submit your statement of intent to comply with 21 CFR 314.70(a)(4) to the following address or by facsimile at 301-847-8444:
