

Adoption of the FDA Food Code by State and Territorial Agencies Responsible for the Oversight of Restaurants and Retail Food Stores



The Food and Drug Administration's (FDA) National Retail Food Team (NRFT) monitors adoption of the FDA Food Code by State and Territorial regulatory agencies in the United States responsible for the regulation of restaurants and retail food stores. Adoption of the Food Code represents a successful federal/state/local partnership in improving food safety and signals commitment to the goal of preventing and reducing the incidence of foodborne illness in retail and foodservice establishments in the United States. FDA Retail Food Specialists (Specialists) assess the Food Code adoption activities within each State and territory. The Center for Food Safety and Applied Nutrition (CFSAN) compiles the information gathered by these Specialists into a report that includes which version of the FDA Food Code has been adopted by each State and Territorial regulatory agency. Note that this Report uses two terms to describe the Food Code – 'version' and 'edition'. The term 'version' is associated with the year of publication/release and the term 'edition' is associated with the number of times the Code has been published in its current format. So, the 1993 version is the 1st edition, the 1995 version is the 2nd edition, the 1997 version is the 3rd edition, the 1999 version is the 4th edition, the 2001 version is the 5th edition, the 2005 version is the 6th edition, the 2009 version is the 7th edition, the 2013 version is the 8th edition and the 2017 version is the 9th edition.

## States and Territories Monitored for Food Code Adoption Status in 2019

#### Geographic Scope:

All 50 States, the District of Columbia (DC), Guam, Northern Marianas Islands, Puerto Rico, American Samoa, and U.S. Virgin Islands.

#### States and Territories with changes of Food Code adoption status in 2019:

Arkansas, Florida (Department of Business and Professional Regulations), Georgia (Department of Agriculture), Kentucky, Mississippi (Department of Health), New Hampshire, Ohio, Pennsylvania, Puerto Rico, South Carolina, United States Virgin Islands, and West Virginia. Rulemaking in District of Columbia, Delaware, Florida (Department of Agriculture and Consumer Services), Kansas, Michigan, Nebraska, Virginia, and Washington started in 2019 with intent to adopt 2017 Food Code or 2017 Food Code as modified by the Supplement (still in progress).

## State Agencies with Oversight of Restaurants and Retail Food Stores

For the purposes of this report, "District of Columbia Department of Health/Health, Regulation and Licensing" is considered as a State agency. There are 64 State agencies responsible for providing regulatory oversight of either restaurants, or retail food stores, or both. A State may give regulatory oversight to multiple agencies within that State, each assigned to regulate different segments of the retail food industry. For example, a state may have:

- A single regulatory agency with responsibility for both restaurants and retail food stores.
- Two regulatory agencies with responsibility for both restaurants and retail food stores.
- A regulatory agency with responsibility for restaurants but not retail food stores; and another regulatory agency with responsibility for retail food stores but not restaurants.
- A regulatory agency with responsibility for both restaurants and retail food stores; and another regulatory agency with responsibility for retail food stores but not restaurants.
- Two regulatory agencies with responsibility for both restaurants and retail food stores; and another regulatory agency with responsibility for restaurants but not retail food stores.

Of the **64** State regulatory agencies:

- a) **46** agencies are responsible for both restaurants and retail food stores; 45 out of these 46 have adopted the FDA Food Code, with California Dept. of Public Health, Food & Drug Program the only exception.
- b) **Eight** agencies are responsible for restaurants, but not retail food stores; 7 out of these 8 have adopted the FDA Food Code, with New York State Department of Health the only exception.

c) **10** agencies are responsible for retail food stores but not restaurants; all 10 agencies have adopted the FDA Food Code.





Figure 1: State regulatory agencies have responsibility for oversight of restaurants, and retail food stores.

Figure 1 depicts the number of agencies per State with regulatory oversight for restaurants and retail food stores.

Specific details include:

- There are **38** States and DC with a single State regulatory agency responsible for regulating restaurants and retail food stores.
- There are **12** States that have multiple regulatory agencies, with details provided below:
  - **One** State (**FL**) has **three** agencies, where:
    - Two agencies are responsible for both restaurants and retail food stores.
    - One agency is responsible for restaurants.
  - Three States (CT, MS, OH) have two agencies, where:
    - One agency is responsible for both restaurants and retail food stores.
    - One agency is responsible for retail food stores.
  - Seven States (GA, ME, NY, OR, TN, UT, VA) have two agencies, where:
    - One agency is responsible for restaurants.
    - One agency is responsible for retail food stores.
  - **One** State (**MN**) have **two** agencies, where:
    - Two agencies are responsible for both restaurants and retail food stores.

#### Summary of Status on State Adoption of the FDA Food Code

Figure 2 reflects the most recent Food Code version that was adopted in each State regulatory agency. Each State has at least one agency that has adopted the FDA Food Code, with California the only exception.



**Figure 2:** FDA Food Code versions Adopted by States in 2019. If a State has multiple agencies, this map displays the agency that has adopted the most recent version of FDA Food Code: (1) FL has three agencies: one adopted 2017 version, one is still working on adoption of 2017 version, and one adopted 2013 version; (2) GA has two agencies: one agency adopted 2017 version, the other agency adopted 2013 version; (3) MS has two agencies: one agency adopted 2017 version including the Supplement to the 2017 version, while the other agency adopted 2013 version; (4) NY also has two agencies: one agency adopted 2001 version, the other agency not adopted FDA Food Code; (5) These eight States each of them has two agencies and both agencies adopted same Food Code version, they are: CT,ME,MN,OH,OR,TN,UT,VA.

Note: \*-- DC, DE, KS, MI, NE, and VA started adoption of 2017 version, and are still working on it; and WA is working on adoption of 2017 version including the Supplement to the 2017 version."

Specific details regarding the Food Code versions adopted by different State regulatory agencies (as of 12/31/2019) are provided below.

- The **2017** Food Code is the most recent version adopted in **eight** States: Florida (one of three agencies), Georgia (one of two agencies), Illinois, Mississippi (one of two agencies), New Hampshire, New Mexico, Pennsylvania, and South Carolina.
- The **2013** Food Code is the most recent version adopted in **21** States: Alabama, Arkansas, Colorado, Connecticut (both agencies), Delaware, Hawaii, Idaho, Iowa, Kentucky, Massachusetts, Minnesota (both agencies), Missouri, Montana, North Dakota, Ohio (both agencies), Oklahoma, Rhode Island, Texas, Utah (both agencies), and Virginia (both agencies), and West Virginia.
- The **2009** Food Code is the most recent version adopted in **12** States and DC: District of Columbia, Kansas, Maine, Maryland, Michigan, Nebraska, Nevada, North Carolina, Oregon (both agencies), Tennessee (both agencies), Washington, Wisconsin, and Wyoming.

- The **2005** Food Code is the most recent version adopted in **two** States: Alaska, and New Jersey.
- The 2001 Food Code is the most recent version adopted in four States: Indiana, Louisiana, New York (one of two agencies), and Vermont.
- The **1999** Food Code is the most recent version adopted in **one** State: Arizona.
- The **1995** Food Code is the most recent version adopted in **one** State: South Dakota.
- Additionally, District of Columbia, Delaware, Florida (Department of Agriculture), Kansas, Michigan, Nebraska, and Virginia (both agencies) started 2017 Food Code adoption but are still in progress; and Washington started 2017 Food Code and the Supplement to the 2017 Food Code adoption but is still in progress.

Of the 64 State regulatory agencies from 50 States and the District of Columbia (DC), 62 State agencies have adopted codes patterned after the 1995, 1999, 2001, 2005, 2009, 2013, or 2017 versions of the FDA Food Code; whereas 2 State agencies have not adopted the FDA Food Code. Table 1 lists the details.

## Summary of Adoption Method of the FDA Food Code




Figure 3: The adoption method of rulemaking by State.

Figure 3 displays how the FDA Food Code was adopted among the state regulatory agencies' rulemaking process.

Specific details regarding the adoption methods of State regulatory agencies are provided below.

- **25** States and DC used <u>long-form</u> (a.k.a. *FDA Food Code was used by section-by-section reference*) format: Alaska, Arizona, Arkansas, Delaware, District of Columbia, Georgia, Hawaii, Indiana, Kansas, Louisiana, Maine, Maryland, Minnesota, Nebraska, Nevada, New Jersey, New Mexico, Ohio, Oklahoma, Oregon, South Carolina, South Dakota, Texas, Vermont, Washington, and Wyoming.
- **23** States used <u>short-form</u> (a.k.a. *FDA Food Code was adopted by reference*) format: Alabama, Colorado, Connecticut, Florida, Idaho, Illinois, Iowa, Kentucky, Massachusetts, Michigan, Mississippi, Missouri, Montana, New Hampshire, North Carolina, North Dakota, Pennsylvania, Rhode Island, Tennessee, Utah, Virginia, West Virginia, and Wisconsin.

- **One** State with multiple agencies but only one agency used long-form format to adopt FDA 2001 Food Code • whereas the other agency did not use any edition of FDA Food Code: New York.
- **One** State did not adopt FDA Food Code: California Department of Public Health, Food & Drug Program • Food Code is modeled after the FDA 2001 version Food Code, but it is not equivalent.

#### Summary of the Food Code Adoption Changes by Population and Number of States

For the purposes of summary by State and population calculation, if a State has multiple agencies as of 2019, we count the agency that has adopted the most recent version of FDA Food Code. For example, two New York agencies are responsible for providing regulatory oversight of restaurants and/or retail food stores; while one agency adopted FDA 2001 Food Code whereas the other agency did not adopt FDA Food Code; we consider New York as a State which has adopted FDA 2001 Food Code.

As of 12/31/2019, 10 States have completed Food Code adoption related rulemaking in 2019 (see details in Table 2); and seven States and DC had Food Code adoption related rulemaking activities but are still in progress (see details in Table 3).


- Four States changed Food Code adoption status from previous version to 2017 version: FL, GA and SC are • from 2013 version; NH is from 2009 version.
- Three States changed Food Code adoption status from previous version to 2013 version: KY, and WV are • from 2005 version. AR is from 2009 version.
- Two States changed Food Code adoption status from 2017 version to the 2017 version modified with the • Supplement: MS and PA.
- **One** State changed Food Code adoption status from 2013 version to the 2013 version modified with the • Supplement: OH.
- Seven States and DC started rulemaking and are working on Food Code adoption from previous version to • 2017 version or to the 2017 version modified with the Supplement: DC, DE, FL, KS, MI, NE, VA and WA.

# **Territorial Agencies' FDA Food Code Adoption**

As of 12/31/2019, two territorial agencies (Puerto Rico and U.S. Virgin Islands) have adopted the current version of FDA Food Code, that is 2017 version modified with the Supplement, and they used short-form format. One territorial agency (Guam) has adopted the 2005 version of Food Code. We do not know the status in American Samoa, and Northern Mariana Islands.
